



## **Did you enrol for BSCM / CPIM Part 1 and / or Part 2 but did not complete your certification yet?**

**Below some facts which could assist you in determining whether some of the exams which you passed are still valid**

- If you completed the Legacy BSCM (when CPIM had 5 modules and learners had to pass 5 exams to earn the certification) it is valid for 10 years from the date you passed the exam – check the expiry date – there could still be time for you to complete CPIM Part 2 and earn your CPIM Certification before your BSCM expires.
- Once you pass the CPIM Part 1 exam you have three years to pass the CPIM Part 2 exam and earn your CPIM Certification.
- If you were enrolled for either CPIM Part 1 or CPIM Part 2 and you have not passed your exam yet, but your portal access has expired, you can ask that your portal access be reinstated.
- Please note that the phase in / phase out and cut-off time frames would supersede the above-mentioned facts.
- If you bought CPIM self-study material and need guidance, pay only the lecture fee and attend classes to complete your studies.

The above would encourage you to complete your current CPIM certification, if you completed Part 1 or started Part 2 a while ago and are not sure whether it is still valid.

## Key Deadlines:

Below are the key deadlines for the current CPIM Part 1 & Part 2 Learning Systems and exams:

**If you did not complete both Part 1 & Part 2 of CPIM 7.0 take note of the following cut-off dates**

- **January 4, 2023:** CPIM 8.0 learning system and bundle presale begins
- **January 31, 2023:** The last day to purchase CPIM 7.0 self-study bundles, CPIM 7.0 Part 1 bundles, CPIM 7.0 combined bundles, CPIM 7.0 Part 1 learning systems and CPIM 7.0 Part 1 exam credits.
- **February 1, 2023:** First day to purchase CPIM 8.0 authorizations to test. Fulfilment of CPIM 8.0 learning systems and bundles begins.
- **April 30, 2023:** The last day to purchase CPIM 7.0 Part 2 learning systems, CPIM 7.0 Part 2 exam credits, and CPIM Part 2 bundles
- **June 1, 2023:** The first day to sit for the CPIM 8.0 exam
- **July 31, 2023:** The last day to purchase CPIM 7.0 ATTs
- **February 1, 2024:** The last day to sit for the CPIM 7.0 Part 1 or Part 2 exams

**Please note that no reasons / excuses / medical conditions / death in the family or anything else would be accepted to postpone one of these dates.**
